## NOTICE OF UTILITY TARIFF FILING

The ALASKA PUBLIC UTILITIES COMMISSION gives notice that the ALASKA EX-CHANGE CARRIERS ASSOCIATION (AECA) has filed a tariff revision (TA18-999) proposing many revisions to Section 31 (Access Service - Rates and Charges) of its tariff.

AECA describes its filing as a restructuring of Section 13 and states that the restructured provisions enhance the tariff's usefulness and minimize confusion regarding the rates charged by individual local exchange utilities. According to AECA, with the exception of Section 13.5 (Labor Rates), there are no new rates for 1993 introduced in this filing.

In Section 13.5 AECA proposes basic time, overtime, and premium time labor rates for twenty-two local exchange utilities for the following categories of services: Additional Engineering; Additional Labor; and Additional Cooperative Acceptance Testing-Switched Access. In some cases the rates vary according to more specific types of service, e.g., installation and repair, standby, testing and maintenance with other telephone companies. AECA states that the proposed loaded labor rates are at the January 1, 1993, prevailing National Exchange Carriers Association rate for all local exchange utilities other than Anchorage Telephone Utility, Bristol Bay Telephone, and average schedule companies.

Some of the proposed labor rates for each half (1/2) hour or fraction thereof are shown below as examples.
