4 AAC 31.062 related to school debt retirement reimbursements to municipalities is amended by adding to subsection (a) requirements stipulating the acceptable form of bond schedules and payment receipts upon which the Department will base state payment action.

The Department of Revenue has identified possible overpayments of state funds under the debt retirement program caused by the lack of sufficient verifable information upon which to base state aid payments. The purpose of this section is to correct such deficiencies.

#### NOTICE OF PROPOSED CHANGES IN THE REGULATIONS OF THE . STATE BOARD OF EDUCATION

Notice is given that the State Board of Education, under authority vested by AS 14.07.080, proposes to repeal, adopt and amend regulations in Title 4 of the Alaska Administrative Code, dealing with the certification of teachers, to implement and interpret AS 14.20.010, AS 14.20.020 and AS 14.20.030, as follows:

4 AAC 12.010 outlines initial criteria for eligibility and fees related to teacher certification in Alaska. The proposed changes in this section add technical language to clarify certification requirements. Certificate fees are amended by organizing all previous sections dealing with fees into one section. 4 AAC 12.010(e) is amended to conform the language which relates to the cause for which a certificate may be denied to the causes for which revocation or suspension is permitted under AS 14.20.030.

4 AAC 12.042 dealing with requirements for a temporary certificate currently allows the department to issue a temporary certificate not to exceed one year to a person who holds a doctorate and who has demonstrated satisfactory teaching in at least three of five years immediately preceeding the application. The proposed regulations would require the applicant to provide evidence of any three years of satisfactory teaching experience, and would eliminate the requirement that the applicant hold a doctorate. This proposed regulation would assist school districts in dealing with teacher shortages, particularly in special education.

4 AAC 12.050, permitting the issuance of vocational trades certificates, and 4 AAC 12.055, permitting issuance of early childhood education certificates, would be repealed. The reason for repeal is that the current regulations are inconsistent with AS 14.20.020, which requires teacher certificates to be based on a baccalureate degree.

4 AAC 12.060, dealing with certificate endorsements defines the circumstances under which the department may endorse a certificate in area(s) in which the applicant is qualified, based upon the recommendation of the preparing institution. In addition to the recommendation of the preparing institution, the proposed regulations would permit the department to accept recommendations from the certifying agency of another state or certificate issuing jurisdiction, and would define the specific areas in which an endorsement could be added. In addition, the commissioner would be permitted to endorse a certificate in a category other than one specifically identified in this section, providing that the applicant provide satisfactory documentation of the particular accomplishment or expertise. (e) of this section would add language permitting the department to endorse an applicant's certificate as a "school psychologist" if the applicant is a Nationally Certified School Psychologist under the National School Psychologist Certification System established by the National Association of School Psychologists. (f) of this section would add the National Association of State Directors of Teacher Education and Certification (NASDTEC) as a program accreditation agency for the "Deaf Education," "Speech and Hearing," "Speech Communication," and "Speech Pathology" endorsement categories. (g) is a new section which would permit the department to remove an endorsement from an applicant's certificate upon the request of the certificate holder and payment of the required fee, provided that the holder is not currently under contract in a position in which the endorsement is required. This section also provides that the endorsement may be added again only if the applicant pays the required fee and meets the current requirements for issuance of the endorsement. These changes are being proposed to provide a manageable number of endorsements, to be able to enter reciprocal agreements with certifying agencies for other states. and to remove endorsements that are not being used upon request by an individual.

4 AAC-12.065 establishes a separate section for emergency certificates under AS 14.20.020(b)(2). It permits an emergency certificate to be issued at the request of a school district only when the district can demonstrate that a qualified person is not available to fill a position requiring a Type A or Type C certificate. School districts are required to show that advertising has occurred in one or more newspapers of general circulation.

4 AAC 12.070, permitting the department to issue a Letter of Authorization in certain circumstances is repealed. Letters of Authorization based on less than a baccalaureate degree are inconsistent with the degree requirements of AS 14.20.010, and emergency certificates have been moved to 4 AAC 12.065.

4 AAC 12.075 is being rewritten and contains technical changes in the requirements for renewal of certificates. Formerly, for a certificate issued after April 9. 1987, an applicant who had not already done so would be required to complete 3 semester hours of Alaska Studies and 3 semester hours of multicultural education in the first renewal period. Only Alaska Studies counted toward the six hour renewal requirement. To simplify the requirement, as amended, the multicultural requirement will be replaced with a requirement of 3 credits in multicultural education or crosscultural communication. All six of these credits would count towards the 6 hour renewal

4 AAC 12.090 is being amended to clarify the effective date for eligibility under perious certification regulations.

4 AAC 12.900 is the definition section of this chapter. It is being amended to add three new definitions for the terms "certifying agency," "preparing institution" and "teacher." These were previously undefined in regulation.

4 AAC 30.020 is adopted in a separate chapter from teacher certification to identify criteria for student teachers and interns, supervision requirements and the contact that a student teacher or internmay have with students without direct supervision. This is a technical change in combination with the repeal of the Letters of Authorization section.

4 AAC 09.010, PUBLIC SCHOOL FOUN-DATION PROGRAM is amended by adding a new sebsection (f) describing Department procedures for resolving underpayments and overpayments to school districts under the public school foundation program.

The purpose of adding a new subsection (f) is related to resolving audit findings in which the Department may have overpaid or underpaid school districts under the Public School Foundation Program during the preceding flacal year. It is necessary that school districts take timely actions to resolve any issues of underpayment of funds. It is also incumbent upon the Department to recover any state funds overpaid. The subsection is added to clarify the Department process and bring official closure to audit findings.

4 AAC 09.120. BUDGET REVIEW is amended to require school districts to rebalance their annual operating budget following completion of the prior year audit if fund balances initially budgeted as revenues were outstated and result in a deficit expenditure plan.

The purpose of this addition is to allow the Department to act consistently with the budget review provisions contained in this section as additional and pertinent information from annual audits is received.

4 ACC 09.160 FUND BALANCE is amended by adding federal impact aid as a category of reserved fund balance.

This change permits federal impact aid subject to state adjustment under the Public School Foundation Program to be properly treated in audits and an allowable reserve in the fund balance.

Experience indicates that such data when compared to audited data is not useful for state budgeting purposes. Repealing the requirement relieves school districts of the additional reporting burden.
