REGULATORY PROPOSALS  
July 11, 1969

To be considered for adoption by the Department of Fish and Game at a meeting at Juneau, Alaska, starting on August 13, 1969.

Attached for your information are proposed regulations for COMMERCIAL FISHERIES. These proposed regulations will be considered for final adoption, amendment, or repeal by the Department of Fish and Game, Support Building, Juneau, starting at 9 a.m. August 13, 1969.

Pursuant to the Administrative Procedure Act, public comment is invited on these proposed regulations. Comments must be submitted to the Department of Fish and Game in writing, as oral comments will not be received at the public meeting on August 13, 1969. Written comments should refer to the specific proposal and be received by the Department of Fish and Game on or before August 11, 1969, so they can be reviewed prior to the meeting. NOTICE OF PROPOSED CHANGES  
IN THE REGULATIONS OF  
THE ALASKA DEPARTMENT OF  
FISH AND GAME

Notice is hereby given that the Alaska Department of Fish and Game, under authority vested by AS 16.05.690, proposes to adopt regulations in Title 5 of the Alaska Administrative Code as follows:

(1) 5AAC 39.130. is amended to read:

(a) Each person, company, firm or organization who purchases unprocessed fish, or processes fish or by-products of fish must:

1. Furnish to the Department each calendar year before operating a written statement of intent to operate with a description of the nature extent, and location of the operation on forms available from the Department.

2. Submit, no later than January 31, an accurate and complete summary of the previous year's operation on statistical forms available from the Department.

A. Reports not submitted for 1967 and 1968 or either one of these years must be submitted by September 30, 1969.

3. Furnish, verbally or in writing, purchasing or processing records as requested by the Department or its representative.

(b) Each buyer of fish or shellfish shall keep a record of each purchase on fish tickets or other forms supplied by the Department of Fish and Game. Fish tickets shall be submitted to the local department representative at least once a week or as otherwise specified by the Department for each particular area and fishery. The record shall include the following:

1. The name of the company or individual buying the fish.

2. The name of the fisherman from whom the fish were purchased.

3. The name or Coast Guard number of the vessel employed in taking the fish.

4. The date of landing of the fish.

5. The Department registration number or set net number, whichever is applicable.

6. The type of gear by which the fish were taken.

7. The nearest headland or bay or statistical catch area in which the fish were taken.

8. Information applicable to the following species:

A. The number of salmon by species when fish are purchased by pound.

B. The number of pounds of king, dungeness and tanner crab.

C. The pounds of other fish or shellfish by species.

9. Such other information as the Department may require.

(c) Each fisherman shall furnish to the buyer factual catch data necessary for completion of reports required by the Department.

(d) Each shellfish fisherman shall furnish in writing to the Department, directly or through the buyer, data necessary for reports required by the Department.

(e) The following information regarding the transporting of unprocessed fish shall be transmitted to an authorized representative of the Department either verbally, in writing or by telephone:

1. The number and species of salmon taken in any regulatory area shall be reported before being transported to any other area or out of the state.

2. The numbers or pounds by species of all other fish shall be reported before being transported out of the state.

(f) Seven days before moving the location of operation, floating fish

processing vessels must report verbally, in writing, or by telegram to the nearest Department office. The report shall include the present processing location and the exact latitude and longitude of the location of the operation.

Notice is also given that any person interested may present written statements or arguments relevant to the action proposed in the auditorium of the Support Building, Juneau, Alaska, before 9 o'clock a.m. on August 13, 1969, at which time a public meeting will be held. Oral comments will not be received at this meeting. The Alaska Department of Fish and Game, upon its own motion or at the instance of an interested person, may thereafter adopt the proposal substantially as set out above without further notice.

## Wallace Asks Good, Solid Questions of Rep. Hensley

Rep. William L. "Willie" Hensley, Kotzebue Democrat Eskimo legislator, was kept busy for two days last week in Kotzebue by the Columbia Broadcasting System team of Mike Wallace and Paul Lowenwater who are filming on the theme of Alaska native land claims in Alaska.

Wallace and Lowenwater were alerted to the land claims matter after reading about the land troubles of Chief Andrew Isaac and his people in the Tanacross area in the Tundra Times.

"We came up here to get the story of the oil strike but we have found other interesting subjects going on in Alaska," Lowenwater told Tundra Times recently. "For instance the story about Chief Isaac of Tanacross and the native land problems."

Lowenwater inquired wheth-

er Chief Andrew Isaac would be able to face up to a strong personality like Mike Wallace, who is famed for his point blank type and searching questions in his CBS program.

He was told that Chief Isaac would be more than able to do so as he was a strong and positive leader of his people and that his only drawback would be his inability to talk smoothly in English but that he was well able to put his points across nevertheless.

After a previous visit to Tanacross, the CBS team again visited the village last Sunday to film more scenes of Chief Isaac and his people.

"They were in Kotzebue for two whole days and Mike Wallace asked me some good, solid questions," said Rep. Hensley.
