AMMENDED NOTICE OF PROPOSED CHANGES IN REGULATIONS AND OF A PUBLIC MEETING

COMMERCIAL FISHERIES ENTRY COMMISSION

Notice is given that the Alaska Commercial Fisheries Entry Commission, under the authority of AS 16.43.100 and .110(a) proposed to adopt, amend, renumber or repeal regulations in Title 20, Chapter 05 of the Alaska Administrative Gode to implement and interpret AS 16.43.100, .100, .150, .170, and .220 as follows:

- 20 AAC 05.440 is repealed. This section allows fishers to continue using a permit card until January 31 of the next year if the permit is issued for a fishery that extends beyond December 31. The commission proposes that this provision is no longer necessary, because the licensing system is fully automated and permit cards for the next season are available by the previous fall;
- 2. 20 AAC 05.1718(a)(1) is amended to eliminate unnecessary wording and to conform the terms of the regulation to its authorizing statute. AS 16.43.170(g)(1);
- 3. 20 AAC 05.1845(d) is amended to correct the reference from 20 AAC 05.1830 to AAC 05.1840; and
- 20 AAC 05.1910(g) is amended to change the fee required to receive a duplicate metal ADFG vessel number plate from \$10 to \$2 to comply

with AS 16.95.520.

NOTICE OF UTILITY TARIFF FILING

The ALASKA PUBLIC UTILITIES COMMISSION gives notice that the ALASKA EX-CHANGE CARRIERS ASSOCIATION (AECA) has filed a tariff revision (TA27-999) to add to its tariff provisions for 900 Blocking service and a description of its existing Interim NXX translation charge.

The AECA begins its description of 900 Blocking service with the following language:

The Telephone Company will provide 900 Blocking Service to customers who obtain local exchange service from the Telephone Company under general or local exchange tariffs and to customers who obtain Feature Group A Switched Access service under this [AECA] tariff.

The AECA proposes a \$11.00 nonrecurring charge per exchange service line, or trunk and/or per Feature Group A Switched Access Line for 900 Blocking service. The AECA proposes that blocking access to 900 service be offered to all subscribers at no charge at the time telephone service is established at a new number and for 60 days thereafter. An example of the proposed language describing Interim NXX Translation follows.

The Interim NXX Translation rate element provides for customer identification of nondata base services when calls are directed by end users in the 1+SAC+NXX-XXXX (e.g., 1+900+NXX-XXXX) format. The NXX codes are assigned to specific customers in conformance with the North American Numbering Plan (NANP). NXX code assignment(s) will be made by the Bellcore NANP Coordinator. The Telephone Company will use the NXX code to identify the customer to whose point of termination the traffic is to be delivered, (i.e., at appropriately equipped electronic end offices, access tandems or through tariffed arrangements with other parties.) It is then the responsibility of the customer to do any further translation the customer deems necessary to route the call. Customer assigned NXX codes which have not been ordered will be blocked.

If after investigation the Commission finds a rate or classification different from that proposed by the AECA is reasonable, the Commission may approve a rate or classification which varies from that proposed.

ment with the AECA. The Commission considers comments in determining the appropriate action to be taken. Filing comments will not make a person a party to the proceeding. To become a party, one
