PUBLIC NOTICE RS 2477 NOMINATION

The Division of Land has received an application for the nomination of the following route for certification as an RS 2477 right-of-way under 11 AAC 51.010-.020 and hereby provides notice of the application pursuant to 11 AAC 51.030.

Marvel Creek Cat Trail, RST 5: This trail runs from a point on Aniak Slough, one mile south of City of Aniak, thence southerly along the Aniak and Salmon Rivers, a distance of 50 miles. Thence westerly on Eagle Creek, thence northerly on Marvel Creek, past the airstrip, thence easterly on Dominion Creek, forming a loop in the southern terminus of the trail. Most of the trail is shown on U.S. Geological Survey maps, Russian Mission A-1, B-1&2, C-1 and Bethel D-1&2. The trail is also shown in the Department of Transportation and Public Facilities Trails Inventory on map 59 (Bethel quadrangle), trail 7, and on map 73 (Russian Mission quadrangle), trail 7.

The evidence compiled in the case file for this trail supports acceptance of the federal RS 2477 grant of right-of-way. This determination is based on the requirements of 11 AAC 51.060 and applicable law for public use and/or construction of the route while the land was unreserved federal land.

The Division of Land invites the public to comment on past use and construction of this route. In addition, any person may request an informal adjudicatory proceeding for the purpose of presenting additional factual information about this trail. The deadline for comments or a request for an informal adjudicatory proceeding is 60 days from the date of publication.
