# Water Program Starts Flowing

A program designed to solve the severe problems to safe drinking water and adequate waste disposal in Arctic villages will begin in February, Senator Stevens announced.

Senator Stevens, who cosenator Stevens, who co-sponsored the \$1 million project, said, "This is a great step for achieving a higher standard of living in our native villages. These services – which many of us view as essential have us view as essential – have been unavailable in the arctic. This is just the beginning of bringing modern comforts – indeed, necessities – to all Abeliant Alaskans

The program called the Village Demonstration Project will be administered by the Environmental Protection Agencies National Environmental Research Center. Initially, two villages, Emmonak and Wain-wright, will be involved in the test program.




