#### PUBLIC NOTICE OF INFORMAL CONFERENCE FOR THE SURFACE COAL MINE PERMIT

The State of Alaska, Department of Natural Resources has been requested to hold an informal conference to allow additional public comment on an application for a surface coal mining permit submitted by Diamond Shamrock Chuitna Coal Joint Venture. The informal conference was requested by the Trustees For Alaska and the Tyonek Native Corporation as provided for under AS 27.21.140 and 11 AAC 90.115.

The informal conference will be held at 7:00 pm, November 24, 1986 in the Assembly Chambers of the Loussac Library, 3600 Denali Street, Anchorage, Alaska 99503. The informal conference is open to the general public and any person who is or may be adversely affected by the issuance of the permit may give a statement. Oral or written statements will be accepted until the close of the conference. A statement may also be filed by writing to Mr. Samuel M. Dunaway, Jr., Department of Natural Resources, Division of Mining and Geology, P.O. Box 7016, Anchorage, Alaska 99510, but the statement must be received before the close of the conference.

Diamond Shamrock Chuitna Coal Joint Venture proposes to develop a surface coal mine in the Beluga region of upper Cook Inlet. The project area is located on the northwest side of Cook Inlet, approximately 45 miles west of Anchorage, Alaska. The proposed permit area includes the following lands:

The applicant has requested a ten year permit and intends to start production in 1989. The coal will be strip mined using large shov's and draglines, transported to a mine service area by conveyor and then crushed and loaded onto an eleven mile conveyor for transport to a port facility on Cook Inlet. The eleven mile conveyor system and port facility will not be part of the mine permit but will be covered by other state and federal permits. The permit area consists of approximately 3,596 acres. A maximum of 600 acres would be disturbed at any one time.

All disturbed areas will be restored to their approximate original contour and reclaimed as wildlife habitat. The applicant has requested a variance from the requirements under 11 AAC 90.311 to separately remove and salvage topsoil.

The applicant is subject to the requirements of the Alaska Surface Mining Program, AS 27.21 and 11 AAC Chapter 90. The application was found to be complete and is currently being reviewed to determine if it meets the technical requirements of the Alaska Surface Coal Mining Program. Revised application materials were submitted after the initial public review period and will be considered in the state's decision.
