Northwest Inuplat Housing Authority (N.I.H.A.) will receive sealed bids for Building Materials to be divided and marked in Three separate packages as indicated in Materials List, until May 8, 1989, 2:00 p.m. at the office of the Northwest Inuplat Housing Authority. At which time and place all bids will be publicly opened and read aloud. Sidders shall be responsible for own bid preparation costs.

2. A complete listing of materials required by each village, that is to be separated for shipping, is included in the bid packet. The material will be F.O.B. Village. Shipment schedule to the villages will be as follows: Noorvik, Klana and Selawik, July 1989. After Notice to Proceed to supplier, thirty-five percent (35%) of bid price will be paid upon inspection of materials by an authorized NIHA representative and proof of shipment with invoice and the balance to be paid within seven days of acceptance at Village. All materials will be inspected by authorized NIHA staff at Village before acceptance of Material. NIHA staff reserve the right to refuse any damaged material.

5. The Northwest Inuplet Housing Authoritieserves the right to reject any and all bide or

waive any informalities in the bidding. No bid shall be withdrawn for a period of thirty (30) days subsequent to the opening of bids without the consent of the Northwest Inuplat Housing Authority.

6. Indian-owned firms or enterprises will be given preference in the award of this contract. The preference will be as defined in the Indian Preference Schedule which is included in the Bid Packet. To qualify as an Indian-owned enterprise the Bidder must sibrnit with the Bid, documentation as required by 24 CFR 905.204(b) which is described int he instructions to Bidders.

7. The Successful bidder must have proven administrative and financial capability to deliver all the material to all the villages in a professional manner by July 31, 1989. All bide must include the required submissions listed in the bid packet.

8. The work to be performed under this contract is on a project subject to Section 7(b) of the Indian Self-Determination and Education Assistance Act 25 U.S.C. 450e (b) Section 7(b) requires that to the greatest extent leasible (1) preference and opportunities for training and employment shall be given to Indians, and (2) preference in the award of contracts and subcontracts shall be given to Indian organizations and Indian-owned economic enterprises.

(a)The contractor must provide preference in employment and training opportunities created as a result of this contract by hiring qualified Indians in all positins other than core crew positions except where the contractor adequately advertises a positin and no Indian either qualifies or accepts the terms of employment. Adequate advertisement is defined as notifying the housing authority and Manillaq Employment office for a period of 3 (three) days. A core crew employee is an individual who is a bone fide employee of the contractor or subcontractor at the time the bid or proposal is submitted, but who is regularly employed by the contractor or subcontractor in a supervisory or other Key skilled positions when work is available.

If no employment or training opportunities are created as a restut of this contract the bidder must so certify in the bid submission. Northwest inuplet Housing Authority will evaluate the certification and accept or reject it.

If training and employment opportunities will be available, the bidder must submit a statement detailing their employment and training opportunities and their plans to provide preference to indians including the number or percentage of indians anticipated to be employed or trained. Additionally, the bidder must submit a list of all core crew employees with its bid. In order to be acceptable to the Northwest Inupiat Housing Authority the statement must provide for fifty percent inclan employment exclusive of core crew positions.

(b) The contractor must provide preference in the award of any subcontracts by using the procedures outlined in 24 CFR Part 905.204 (c) (1) (ii) (copy attached). If no subcontract will be awarded, the bidder must so certify in the bid submission. Northwest inupiat Housing Authority will evaluate the certification and accept or reject it.

If subcontracts will be awarded, the bidder must submit with the bid a statement describing how preference in the award of subcontacts will be proincled. For the statemet to be determined adequate by the Northwest Inuplat Housing Authority it must include the procedures outlined in 24 CFR 905.204 (c) (1) (ii) (copy attached).

(c) Failure to either submit the certifications or acceptable statements required in item 9. (a) (b) above will be grounds for determining the bid is non-responive. Failure to comply with the undertaking set out in the statements, awarding a subcontract without using the prescribed procedures or through faise representation shall be grounds for terminating this contract.

(d) Northwest Inuplet Housing Authority does not maintain a list of Indian-owned firms.

(e) Bidders are advised to contact the village corporation governing body to determine any applicable Indian preference requirements of that village corporation body.
