NOTICE TO MINING CLAIM OWNERS

Your Mining Claim Will Be Void...

if located on federal land unless you file a copy of your location certificate with the Bureau of Land Management (BLM) as well as the local recorder.

If You Located a Mining Claim After October 21, 1976

vou have 90 days from date of location to file with BLM.

If You Located a Mining Claim Before October 22, 1976...

you have until October 22, 1979 to file with BLM. If you recorded your claim with BLM during calendar year 1977, your assessment will be due December 30, 1978. It will also be due every year on the same date.

You Are Required to File with BLM

1. A copy of location recorded in the local records:

- 2. A statement providing the legal description, including township, range, meridian, state, section, and quarter section;
- 3. A map showing the survey or protraction grids depicting the location of the claim;
- 4. A \$5.00 service fee for each claim.
