This notice may affect your rights. Please read

TO: All Purchasers of Alaska State Housing Authority (ASHA) houses built under the Bartlett Act in Point Hope, Alaska.

Your rights may be affected by a lawsuit pending in this court, Case Number 2KB-84-111 Civil.

In this lawsuit, ELmer Frankson, Harold Koonuk, David Stone, Sr., and Sophie Tuckfield claim that the North Slope Borough unlawfully levied property taxes against them and other purchasers of ASHA houses. They assert that they and other ASHA homebuyers should not have to pay property taxes. on their ASHA houses for any period of time before these houses were deeded to the homebuyers. The claim that because they did not own these homes until October, 1981, state and federal laws prohibited the North Slope Borough from taxing them before that date. They further claim that the North Slope Borough violated various provisions of the Alaska constitution because it taxed the ASHA homebuyers of Point Hope, but did not tax the ASHA homebuyers of Wainwright who were similarly situated.

The ASHA homebuyers who brought this lawsuit are asking that the court find that they do not owe taxes on their ASHA houses for any time before October, 1961, the date the houses were deeded to them. They are also asking that the court order the North Slope Borough to stop foreclosing on their houses because of taxes which were not paid before October, 1981. They are also asking the court to order the North Slope Borough to refund all taxes paid by them because of tax assessments on thier houses before October, 1981. The North Slope Borough denies all of these claims and charges.

The court has not yet decided which side is right in this case. The court has made no decision about Elmer Franktion's, Harold Koonuk's, David Stone, Sr.'s, and Sophie Tuckfield's charges and claims, or about the North Slope Borough's denials and defenses. The court has, however, made a decision that affects the rights of ASHA homebuyers in Point Hope. You have been identified as a possible ASHA homebuyer, and that is why you have received this notice. The following will explain how this lawsuit may affect your rights and what choices you must make.

CLASS ACTION RULING

The court has ruled that this lawsuit may be maintained as a class action. The court has named Elmer Frankson, Harold Koonuk, David Stone, Sr., and Sophie Tuckfield as class representatives, and their attorney, Alaska Legal Services Corporation, as counsel for the class.

The class is made up of those persons who brought ASHA houses, and were taxed by the North Slope Borough for the years before they received title to those houses. If you were an ASHA homebuyer, and your house was taxed by the North Slope Borough for any of the time before October, 1981, the date you got title to your house, then you are a class member.

If you are a class member, this does not mean that you will necessarily get a refund of money you paid in taxes befoe October, 1981, or that you will get any of the other relief requested by Elmer Frankson, Harold Koonuk, David Stone, Sr., and Sophie Tuckfield. As explained above, the court has not yet decided the issues of this case. Rather, what being a class member means is that when the court does decide this case, the court's decision will apply to you. If the court decides in favor of Elmer Frankson, Harold Koonuk, David Stone, Sr., and Sophie Tuckfield, then this decision will apply to all class members as well. If, however, the court decides in favor of the North Slope Borough, then this decision would apply to all class members as well. Whatever decision the court makes, wnether favorable or unfavorable to the class, will be binding on all class members.

If you want to remian a member of the class, you do not need to do anything at this time. By remaiing a clas member, any claims that you have against the North Slope Borough for taxing you on your ASHA house before October, 1981, will be decided in this case, and cannot be presented in any other lawsuit.

PIGHTS AND OBILGATIONS OF CLASS MEMBERS

If you remain a member of the class:

(1) Elmer Frankson, Harold Koonuk, David Stone. Sr., and Sophie Tuckfield, will act as your representatives, and their attorney, Alaska Legal Services Corporation, will act as your attorney for the presentation of the claims against the North Slope Borough. If you wish, you can hire your own attorney. You may also seek to intervene individually, without an attorney, and may advise the court if at any time you consider that you are not being fairly and adequately represented by the named representatives, and their attorney, Alaska Legal Services Corporation.

(2) Your participation in any recovery which may be obtained from the North Slope Borough through trial or settlement will depend upon the results of the lawsuit. If no recovery is obtained for the class. you will be bound by that result also.

(3) In order to participate in any recovery through settlement or trial, you may be required to present evidence with respect to taxes and paid on your house. You should, therefore, keep any receipts or other records relating to taxes on your house.

(4) Your will be entitled to notice of any ruling reducing the size of the class and also to notice of, and an opportunity to be heard respecting, any propaged settlement or dismissal of the class claims.
