

**PUBLIC HEARING ON
HAZARDOUS WASTE
SITING REGULATIONS**

The Alaska Department of Environmental Conservation (DEC) will hold a public hearing in Anchorage on Thursday, August 7, from 7 p.m. to 9 p.m. at the Pioneer School House (Third and Eagle Streets), regarding regulations concerning how and where a hazardous waste facility may be located in Alaska.

The proposed regulations will require owners and operators of hazardous waste storage, treatment, incineration, or disposal facilities to obtain a permit from DEC before construction and operation of a hazardous waste management facility. The proposed requirements include:

1. Preapplication notification to the local community;
2. Setbacks from property lines, rights-of-way, waters and water supplies;
3. Risk management;
4. Feasibility and financial responsibility; and
5. Proof that for 1,000 years the public will be protected by natural geologic strata from disposed hazardous waste.
