ALASKANS, please think twice before you vote in the November 2, 1982, General Election. Please vote "No" against the repeal and let our Alaska Board of Game and Board of Fish continue to do a good job managing the fish and game resources in this Great Land. HELP SAVE THE RESOURCE!!!
