

The Office of the Federal Inspector for the Alaska Natural Gas Transportation System is a Federal Agency established to provide regulatory oversight for the design, construction, and initial operation of a gas conditioning plant and chilled gas pipeline from Prudhoe Bay in Alaska to the "lower 48 states," to supply natural gas to the mid-west and west coast. The pipeline and gas conditioning plant will be designed and constructed by private contractors under the purview of the project sponsor (a consortium of pipeline companies). The Logistics Management Specialist will review and monitor the contractor's logistic plans for the Alaska Leg of the project including such areas as major movement of equipment and supplies, material staging and handling, personnel, aircraft support, procurement, etc. This is a G5-12/13 position, with salary ranging from \$28,245 to \$43,366, depending on experience.

Applicants' experience will be evaluated against the following factors:

- Experience handling large scale procurement/transportation problems on a construction project.
- 2. Sealift/bargelift experience.
- Knowledge of overland transportation methods and problems in an arctic environment.
- 4. Experience developing a logistical support plan for semi-remote areas.

Duties will require extensive travel.

Position will relocate to Alaska in 1-2 years.
