Annual Meeting survey:

The members evaluate CEDC

What are the top priorities for rural Alaskans, and how is CEDC meeting those needs? The board and the staff wanted to know. So at the CEDC Annual Membership Meeting last February each member representative was asked to complete a questionnaire.

The results of the questionnaire do not necessarily represent an accurate picture of the opinions of the entire CEDC membership, because the answers were from an unscientific sample and were not anonymous. They do, however, indicate CEDC strengths and weaknesses and how many of the members evaluate the priorities in their communities.

1. What is the major source of jobs in your community?

71% - Fishing

65% - School district

46% - Government
