## NOTICE OF PUBLIC HEARING

### Call for Comments

Notice is hereby given that public hearings will be held regarding the proposed Point Thomson Oil and Gas Lease Sale No. 29A. The area for comment includes lands comprising all or part of the following:

T9N R24E, Sections 2, 3, 4, 9, 10, 15, 16, 21, 28, 29, and 32.

T10N R24E, Sections 3, 10-15, 22-26, 35, and 36 of the Umiat Meridian.

The lands, approximately 11,500 acres, are located on the North Slope and lie immediately west and northwest of the Canning River and extend offshore to the State's three mile territorial limit. Special environmental considerations will be given to all tracts because of expressed cultural and biological concerns.

Interested parties may present oral or written statements relevant to the proposed action at any or all of the following hearings:

4) July 27, 1978 - 7:00 p.m. - Kaktovik, Alaska 99747.
