Alaska State Educational Incentive
Grant
Program Applicants

The Alaska State Educational Incentive Grant Program (SEIG) provides to eligible students enrolled full time in undergraduate programs at in-state and out-of-state postsecondary educational institutions. Grant awards will range from a minimum of \$100 to a maximum of \$1,500 depending upon financial need. Applicants must be at least two year residents of Alaska.

Applications for 1986-87 SEIG grants are available from the Alaska commission on Postsecondary Education, SEIG Program, Box FP, Juneau, Alaska 99811. Students must also complete a 1986-87 Financial Aid Form. Contact the Commission for further application procedures and eligibility criteria.

1986-87 SEIG applications and FAF Needs Analysis Reports must be postmarked by May 31, 1986 for consideration. Applications recieved after that date will not be processed.

NOTICE OF UTILITY TARIFF FILING

The ALASKA PUBLIC UTILITIES COMMISSION hereby gives notice that ARCTIC SLOPE TELEPHONE ASSOCIATION COOPERATIVE, INC. (ASTAC), a telecommunications utility, has filed a tariff revision (TA4-257), which is a proposal to add rates and rules for the sale of customer premises equipment (CPE).

ASTAC proposes the following rules for single line CPE:

- (1) Payment will be made by a single cash payment or charged to the customer's next telephone bill.
- (2) ASTAC warrants the basic instrument and the line cord for a period of 90 days. ASTAC retains the right to repair, replace, or refund the purchase price of the instrument within the warranty period. The warranty does apply under certain conditions such as accidents or abuse. No warranty may extend beyond December 31, 1987.

ASTAC proposes a price of \$10.57 for Touch-Tone instruments.

ASTAC proposes the following terms and conditions for the sale of multiline CPE:

- (1) The purchase price for a multi-line CPE and intrasystem wiring will be a negotiated price.
- (2) Payment may be made by a single payment or by equal monthly payments over three, six, or twelve month periods. Interest on time payments will be at the rate of 1.5% per month on the unpaid balance. ASTAC will retain ownership of the equipment until the full purchase price has been paid.
- (3) ASTAC warrants the multi-line CPE and associated intrasystem wiring for a period of 180 days. The warranty does not apply under certain conditions such as abuse or misuse of the equipment. No warranty may extend beyond December 31, 1987.

If after investigation the Commission finds a rate or classification different from that proposed by ASTAC is reasonable, the Commission may approve a rate or classification which varies from that proposed.

Detailed information may be obtained from the utility whose address is 480 W. Tudor Rd., Suite 105, Anchorage, Alaska 99503. The filing may be inspected at the offices of the Alaska Public Utilities Commission, 420 "L" Street, Suite 100, Anchorage, Alaska 99501-1987.

Any interested person may file a statement of views favoring or opposing this tariff filing with the Alaska Public Utilities Commission. While comments will be considered by the Commission in determining the appropriate action to be taken, they will not serve to make the person a party to the proceeding. Any person wishing to become a party must file a petition to intervene in accordance with Section 3 AAC 48.110 of the Alaska Administrative Code.

To assure Commission consideration of comments or petitions prior to a final decision on this matter, they must be filed by March 17, 1986. Any statement filed with the Commission should clearly affirm that the interested person has filed true copy of the statement with ASTAC.
