Major provisions of the proposed JOBS plan:

The effective dates of the proposed plan will be October 1, 1990 through June 30, 1992.

The plan states that the Alaska Department of Health and Social Services will operate a program intended to help AFDC recipients achieve economic self-sufficiency through participation in basic education, skills training, and other employment-related services.

The plan describes the process whereby AFDC recipients will be offered the opportunity to participate in the state JOBS program.

The plan describes the activities and supportive services available to state JOBS participants.

The plan lists the criteria the Department will use to determine that an AFDC recipient has good cause not to participate in the state JOBS program.

The plan describes the process whereby the Department and an AFDC recipient might resolve disputes regarding failure to comply without having shown good cause.
