This action is not expected to require an increased appropriation.

Action

It is our intent to terminate public easements EIN 5 C4, and EIN 5a C4 as documented in Interim Conveyance (IC) No. 743, dated September 30, 1993.

Legal Description

a. (EIN 5 C4) A one (1) acre site easement upland of the ordinary high water mark in Sec. 18, T. 20 N., R. 39 W., Seward Meridian, on the left bank of the Kuskokwim River.

b. (EIN 5a C4) An easement twenty-five (25) feet in width for a proposed access trail from site EIN 5 C4 on the Kuskokwim River in Sec. 18, T. 20 N., R. 39 W., Seward Meridian, southeasterly to public land.

Background

Section 17 (b) of the Alaska Native Claims Settlement Act of December 18, 1971 (PL 92-203) requires that prior to conveying public lands to Native corporations, the Bureau of Land Management (BLM) must provide public easements where necessary, to allow access to public lands.

Prior to survey, public easements 5 C4, and 5a C4, were reserved from land to be conveyed to The Kuskokwim Corporation in IC 743, in order to provide access to nearby public lands.

Rationale

When easements 5 C4 and 5a C4 were originally proposed by the BLM, it was noted by the Land Use Planning Commission (in a Memorandum dated March 7, 1977) that there was a possibility that easements may not be needed in this location because the Native selection survey may indicate that there is adequate access to public lands.

Survey later revealed that the Kuskokwim River connects with public lands in the NW corner of Sec. 17, T. 20 N., R. 39 W., Seward Meridian, approximately 100 yards from the proposed easements, which allows access to public lands and eliminates the need for an easement. It is therefore recommended that these site and trail easements in section 18 be terminated.
