The North Slope Higher Education Center (NSHEC) invites nominations and applications for the position of Director. The NSHEC is a recently established, locally controlled and funded, public, postsecondary institution serving the educational and professional needs of Alaska's North Slope Borough. The Center provides a wide range of in-service, certificate, and baccalaureate programs and degrees.

The center offers academic credit and related degrees through the University of Alaska Fairbanks (UAF). NSHEC faculty receive affiliate UAF faculty appointments and all courses meet at least minimum UAF standards. It is called the North Slope Higher Education Center, because, at present, it does not have independent status as an accredited institution of higher education.

The Director reports to a Board of Directors, comprised of seven members, who are nominated by the committee located within the Borough's 88,000 square mile jurisdiction and confirmed by the Borough Assembly.

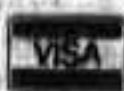
