Notice is given that the State Board of Education, under authority vested by AS 14.07.060 and AS 14.56.020 proposes to amend and repeal regulations in Title 4 of the Alaska Administrative Code, 4 AAC 57.910(a), relating to fees charged by the State Film Library for duplication of instructional materials and 4 AAC 57.920, relating to fees charged by the Alaska Health Sciences Library. The amendments are necessary to implement, interpret, or make specific the provisions of AS 14.56.030 as follows:

1. 4 AAC 57.910(a) currently provides for the State Library to reproduce instructional materials (films or videocassettes) onto videocassettes for schools or school districts at a fee of \$5 per videocassette or a \$250 annual fee for any number of viedocassettes. The proposal is to eliminate the \$250 annual fee, and to authorize a fee of \$25 per video cassette regardless of the number duplicated. The reason for the change is to increase revenues to cover costs. The restriction on service to schools and school districts only will be eliminated.

2. 4 AAC 57.920(a) is amended by changing reference from paragraph (c)(4) to (c). This change will make the section consistent with the proposed changes in 4 AAC 57.920(c).

3. 4 AAC 57.920(b) is repealed. The description of the Table of Content service subscription is included in subsection (c) of 4 AAC 57.920. Other services will not be sold on a subscription basis. Therefore this section can be repealed.

4. 4 AAC 57.920(c) provides for individual subscription fees to four Health Sciences Library services: (1) Besic Services (quick reference; telephone consultation; book loans; malling or materials; interlibrary loan service) -- \$50; (2) Mediline Services (National Library of Medicine searches) - fee table based on number of sear ches; (3) SDiline Services (monthly recurring searches on the same topic in the Medline or Health files) - fee table based on number of searches; and (4) Table of contents Service (copies of tables of contents of selected journals, from which users may select articles to be copied in full) - fee schedule based on number of journals. Under the proposed amendment, there will no longer be a subscription fee for individuals for Basic Services, but there will be a separate fee of \$5 per item for interlibrary loan service; Medline services will not be available on a subscription basis, but there will be a fee of \$15 per search or \$25 per search with abstracts; SDfline services will be \$40 per topic per year or \$50 per topic per year with abstracts; Table of Contents service will be \$20 per title, which includes two copies of articles per issue, or \$10 per titie without copies. The fee for copying journal articles will otherwise be \$2. Special requests, such as rush service will be the cost of the item plus \$5. \$100 paid in advance for these services will entitle the individual to \$120 worth of services. The reason for the proposal to amend this section are to avoid one individual using a subscription to order services for others, and to increase revenues to cover costs.
