Corporation. Those with close communication links with an REAA center but within another and contiguous Native Regional Corporation may resort to referendum to join that center (example: Mentasta).

That portion of SB 35 compelling the Dept. of Community and Regional Affairs to adhere to regional corporation boundary lines is ambiguous at best, since we are in Doyon Limited, the largest regional corporation in the state. Why that requirement of law, when in the sole interest of education establishing school districts with local control, other criteria is more practical. IT SHOULD BE QUITE CLEAR TO OUR STATE LEGISLATORS that ANCSA settled the question of deserved aboriginal rights with land and money, and that Native villages are NOT modern day Indian Reservations, but private property, that the people residing therein are American citizens equal under the law and they are entitled to equal, but not separate consideration in governmental service areas. The mentality of White Fatherism is an affront to other races.

In voicing my concern about the pending boundary decisions to Commissioner McAnery, Dept. of Community & Regional Affairs, in a telephone conversation on Sept. 24, 1975, she assured me there was no thinking in her agency of future state organizational plans; that they were merely pursuing their job as outlined in SB 35. When I inquired as to the reasoning behind their proposed REAA (which would contain a vast area and include 2 district population and business centers, Delta and Tok) she replied that it was proposed to expedite matters. Since we have until July 1, 1976 to comply with SB 35, it is my feeling that expediency can well give way to achieving the true intent of SB 35. The forming of manageable service areas with local control.

It was obvious from the testimony given at the Dept. of Community and Regional Affairs public hearing at Tok on 9/21/75, by an overwhelming majority vote (showing of hands) that a public mandate was given by the residents of Tok and representatives from Eagle, Mentasta, Tanacross, Dot Lake and Northway, that a REAA be formed to include these communities with Tok as the center.

In the present day revolution in education, there are those of us who agree with the statement, that the battle of books in Kentucky will go down in history along with Lexington and Concord. If the noble intent of SB 35 is to succeed and provide the much needed parental guidance of curriculum, discipline, teachers, yes, all aspects of our schools, it is incumbent upon us who will be affected by the coming decisions to stand up and act NOW, to see that the best possible regional education areas are formed to provide local control.

To Hold Informal Hearing— National Marine Fisheries

The National Marine Fisheries Service will hold an informal public hearing at 9 a.m., October 9, in the Civil Service Auditorium, 1900 EE St., N.W., Washington, D.C.

The primary purpose of the hearing is to obtain comments and views on the reissuance of general permits which allow the taking of marine mammals incidental to commercial fishing operations. General permits now in effect expire December 31.

The hearing will deal primarily with the general permit for encircling gear yellowfin tuna purse seining.

Among other items to be discussed are a proposed quota on the incidental take of porpoise, the observer program, and possible modification of existing regulations governing the taking of marine mammals incidental to commercial operations.

At this time, the NMFS proposes to establish a quota within a range of 50,000-110,000 as the number of porpoises that can be killed incidental to the fishing operations if the general permit is reissued.

If a quota is adopted the exact number will be determined by the Director, NMFS, based on the comments and views presented at the hearing and written comments submitted to NMFS.

Bicentennial Medal on Sale

WASHINGTON, D.C. — The official 1975 Bicentennial commemorative medal, authorized by the Congress, goes on sale today.

Available in bronze (\$3.50) and silver (\$15.00), the medal is issued by the American Revolution Bicentennial Administration (ARBA) and produced by the United States Mint.

Orders for the medal should be sent to the American Revolution Bicentennial Administration, P.O. Box 1976, San Francisco, California 94101. A check or money order should be enclosed.

The medal commemorates the famous ride of Paul Revere and depicts the Minuteman Statue on Lexington Common as a tribute to the small band of volunteers who "faced the shot heard round the world."

Net revenues from the sale of the medals are used primarily to support state and local Bicentennial programs around the nation.

Order forms for official 1975 commemoratives can be obtained from local chapters of the Disabled American Veterans, who have joined hands with the ARBA to help raise funds for Bicentennial projects and programs.

The sole authority is vested in the Dept. of Community and Regional Affairs to form the boundary lines.

basis that the allowable kill will, with reasonable assurance, enable the principal stocks of porpoises to increase in size.

The NMFS also proposes to have a full observer program during the coming fishing season if the Marine Mammal Protection Act is appropriately amended and if funds and manpower are available.

It is emphasized that the establishment of a quota and use of a full observer program are only proposals at this time and adoption of these measures is entirely contingent upon a full examination of all pertinent considerations at the public hearing.

The Director, NMFS, will amend existing regulations governing the incidental taking of marine mammals in connection with fishing operations if the general permits are reissued for the 1976 fishing season and if appropriate justification is developed.

Matching Money Available for Bicentennial

WASHINGTON, D.C. — The American Revolution Bicentennial Administration (ARBA) has made available an additional \$40,000 per state in matching grant money for support of Bicentennial projects and programs around the nation.

Totalling \$2.2 million, the money comes from net revenues from the sale of Bicentennial medals and the ARBA's commemorative licensing program.

This is the first matching grant program for fiscal year 1976. However, in it the third increment of \$40,000 in non-appropriated money that has been provided each of the 50 states, the District of Columbia, Puerto Rico, American Samoa, Guam and the Virgin Islands.

In announcing the grants, John W. Warner, administrator of the ARBA, stressed "the need to include programs and projects focusing on the contributions of women, youth, ethnic, racial and Native American groups.

"While many states are showing good progress in these areas," he said, "from a natural perspective some imbalances still exist. We are asking the State Commission to use these funds with special emphasis on correcting these imbalances."
