

To qualify as a candidate for a particular administrative unit the applicant must meet the following criteria:


- 1. Each candidate shall be a shareholder at least 19 years of

COMMITTEE READIES TO OPT V.P. FOR RUR. EDUC.

A selection committee of Native leaders and University of Alaska officials, having narrowed a field of applicants for the newly-created position of Vice President for Rural Educational Affairs, is expected to make recommendations soon to university President Dr. Robert Hiatt.

office, part of the university's reorganization, was initiated in response to a proposal presented to the university last January by the Alaska Federation of Natives. Inc., to deliver higher education opportunities to rural

areas of the state.

Because rural communities have to manage increasingly complex affairs as a result of the Alaska Native Claims Settlement. such as administering corporate structures and local control of education and health services, the AFN proposal calls upon the university to take post-secondary education where rural Alaskans live and work.

The AFN proposal calls for the establishment of 10 regional centers in rural areas and a central office in Anchorage. Cost for the project's first year of operation

would be an estimated \$2.9 million.

The Vice President for Rural Educational Affairs would combine existing rural services into an overall new program to deliver higher education that is responsive to rural needs. One of the duties will be to work with Native organizations to develop regional policy councils which would be involved in planning and developing the new program.

A bill, SB 239, calling for creation of a Vice President for Rural Education and Native Affairs, and an accompanying appropriations bill, SB 240, was introduced in the legislature in March but failed to pass.

The Board of Regents passed a resultion May 9 calling upon Dr. Hiatt to work with the AFN in implementing the concepts in the AFN proposal. Shortly afterwards, Dr. Hiatt announced the creation of the office of Vice President for Rural Educational Affairs, and named an acting head

The position was officially opened to applicants in July. A doctorate requirement was dropped from the original job description after protest that otherwise well-qualified Native educators might be ineligible.

Members of the selection committee who will interview remaining candidates for the position are Chairman Roger Lang, past AFN president; Emil Notti, president of the Alaska Native Foundation; Don Dafoe, executive vice president of the University of Alaska; Gordon Jackson of the AFN; Carolyn Floyd, director of Kodiak Community College; and Dr. James Matthews, director of the university Cooperative Extension Service.


