Alaska's senior Senator Ted Stevens announced that he has sent a questionnaire to Alaskans presently on his mailing list.

"The questionnaire should reach Alaska in a few days," Senator Stevens said and further commented by saying, "I feel it essential that I know the Alaskan viewpoint on problems facing the nation and Alaska while representing Alaska in the Senate."

Senator Stevens said the questionnaire is straight-forward and seeks opinions concerning Alaskan and national issues. The


