**NOTICE OF UTILITY
TARIFF FILING**

The ALASKA PUBLIC UTILITIES COMMISSION hereby gives notice that OTZ TELEPHONE COOPERATIVE, INC. (OTZ), a local exchange telecommunications utility, has filed a tariff revision (TA14-83) which is a proposal to add Billing Control Feature (BCF) service to its schedule of services. BCF service allows a customer to voluntarily restrict long distance billing arrangements. Customers may choose to restrict the following types of long distance calls: dial station, operator handled (e.g. - third number billing, collect, calling card), or both dial station and operator handled.

OTZ proposes a charge of \$20.00 per telephone number to add the BCF service and \$10.00 per telephone number to modify the type of restriction on an existing telephone number; regular applicable service order charges also apply to BCF. OTZ does not propose to charge a monthly recurring rate for BCF service.

If after investigation the Commission finds a rate or classification different from that proposed by OTZ is reasonable, the Commission may approve a rate or classification which varies from that proposed.

Detailed information may be obtained from the utility whose address is OTZ Telephone Cooperative, Inc., P.O.Box 324, Kotzebue, Alaska 99752. The filing may be inspected at the offices of the Alaska Public Utilities Commission, 1016 West Sixth Avenue, Suite 400, Anchorage, Alaska 99501.

Any interested person may file a statement of views favoring or opposing this tariff filing with the Alaska Public Utilities Commission. If you are a person with a disability who may need a special accommodation, auxiliary aid, or service or alternative communication format in order to comment on the proposed tariff revision, please contact Pat Oldenburg at 263-2107 by 4:30 p.m., February 22, 1993, to make any necessary arrangements.

To assure Commission consideration of comments or petitions prior to a final decision on this matter, those comments or petitions must be filed by March 8, 1993. Any statement filed with the Commission should clearly affirm that the interested person has filed a true copy of the statement with OTZ.

While comments will be considered by the Commission in determining the appropriate action to be taken, those comments will not serve to make the person a party to the proceeding. Any person

NOTICE OF APPLICATION FOR APPROVAL
OF THE
WHITE HILLS UNIT**

The Department of Natural Resources gives notice under 11 AAC 83.311 of an application for approval of the White Hills Unit Agreement. The proposed exploratory unit area is located on the North Slope between the Colville River in the west and the White Hills in the east.

The application was filed with the Division of Oil and Gas on December 10, 1992 by ARCO Alaska, Inc., P.O.Box 100360, Anchorage, Alaska 99510, on behalf of itself as the sole working interest owner and designated White Hills Unit Operator.

The White Hills Unit Agreement proposes to conform and modify nine individual State of Alaska oil and gas leases, so the unit operations can be conducted on a unit-wide basis instead of on a lease basis. The nine uplands leases issued in Sale 61 cover approximately 49,597 acres. Should the White Hills Unit Agreement be approved, exploration and development of the unit area would occur in accordance with an approved unit plan of exploration and development.

Approval of the unit agreement would not limit or diminish access to public lands or public or navigable waters beyond any limitations already contained in the individual oil and gas leases proposed to be included in the unit agreement. The White Hills Unit Agreement would have a primary term of five years, and would continue so long thereafter as unitized substances are produced in paying quantities, or other unit operations are conducted under an approved unit plan of exploration and development. Leases committed to the unit would not expire so long as the unit remains in effect. The proposed unit agreement has been executed on a State of Alaska Model Unit A Agreement form, (Revised April 1990) with no modifications proposed by the applicant.

ARCO with 100% working interest in the White Hills Unit proposes to drill one to two exploratory wells in order to evaluate the hydrocarbon potential of the proposed unit area, and to provide geological and engineering data to determine if further exploration and development is warranted in the area. The drilling of the initial exploratory well, Sawtooth Unit No. 1, is scheduled to commence prior to April 30, 1995, and the proposed bottom hole location is with ADL 379057 (T1N-R10E, U.M.). The second exploratory well is planned prior to April 30, 1997.

All or portions of the following lands are included in the proposed White Hills Unit area:

T3N-R9E, U.M., Secs. 4-9, 16-36
T2N-R9E, U.M., Secs. 1-8, 22-27, 34-36;
T1N-R9E, U.M., Secs. 1-3, 11-15, 22-27, 34-36; and
T1N-R10E, U.M., Secs. 19-21, 28-30.

Any person may file written comments on the application. Comments must be received by March 15, 1993, and should be mailed to the Division of Oil and Gas, at the above address, to the attention of Michael D. Kotowski, Units Manager. The Department will review and consider all timely written comments. The unit application will be approved or disapproved considering the criteria contained in 11 AAC 83.303, within 60 days after the close of the public comment period.
