Parcel 2 — 40.00 acres located 20 miles north of Kenai on North Kenai Road.

Parcel 3 — 3.93 acres, situated at the junction of the Paxson — McKinley Park Highway near Cantwell, Alaska.

Parcel 4 — (4) — 10.00 acres tracts located 2.5 miles west of Wasilla, Alaska.

Parcel 5 — Lot 5 containing 80.00 acres located 1.5 miles southeast of Sutton, Alaska on the south side of the Matanuska River.

## A CONFERENCE MULTINATIONAL CORPORATIONS
