NOTICE OF UTILITY APPLICATION

The ALASKA PUBLIC UTILITIES COMMISSION hereby gives notice that UNITED UTILITIES, INC. (UUI), has filed an application (Docket U-82-57) for an amendment of Certificate of Public Convenience and Necessity No. 249 to extend its authority to include the provision of radio paging and improved mobile telephone service. UUI proposes to provide the radio paging and improved mobile telephone service in a region generally referred to as Southwestern Alaska that includes the Calista Region, Bristol Bay Region and Bering Straits Region under Alaska Native Claims Settlement Act (ANCSA) excluding those areas served by other local telephone utilities providing local exchange telecommunications services.

The tariff rates for the proposed services are in part: IMTS radio telephone (fixed) including thirty minutes of air time per month — \$75.00 per month, additional air time (IMTS) — \$75 per minute; tone only pager includ-

ing 30 messages per month — \$50.00 per month; voice and tone pager including forty messages per month — \$60.00 per month; access to telephone network, residential — \$17.50 per month, business — \$27.50 per month.

The Commission notes that an application to provide telecommunications (radio paging) services statewide has also been filed by Radio Communications, Inc. (Docket U-81-83).

More detailed information may be obtained from UUI whose address is P.O. Box 4-2730, Anchorage, Alaska 99509. The complete filing also is available for inspection at the offices of the Alaska Public Utilities Commission, 420 "L" Street, Suite 100, Anchorage, Alaska 99501.

Any interested person may file with the Commission by 4:00 p.m., January 3, 1983, a statement of views and specific reasons in favor of, or in opposition to the granting of authority to the applicant to provide radio common carrier ser-

vices, together with written confirmation that the same statement has also been delivered or mailed to the applicant. In addition, any person wishing to file a competing application must file a notice of intent to do so within 30 days of this notice; i.e., by 4:00 p.m. January 3, 1983, and the application itself must be filed within 90 days of the date of this notice; i.e., by 4:00 p.m., March 5, 1983. Both a copy of the notice of intent and the application must be timely served on the applicant, and written confirmation thereof filed with the Commission.
