These regulations establish guidelines for: funding; income eli-

gible; dwelling eligibility; contracting; per dwelling expense limitations; eligible improvements; administrative expenses and program administration. Known changes recommended by the Department of Law will be presented at the hearings.

On November 4, 1982, the Kokhanok Village Council, the recognized appropriate village entity for the village of Kokhanok, adopted a resolution requesting the Commissioner of the Department of Community and Regional Affairs, acting as trustee for the future municipality of Kokhanok, Alaska, in accordance with AS 44.47.150 (b), to grant a public airport lease and right-of-way for the above described parcels of land to the State of Alaska, Department of Transportation and Public Facilities for the construction, operation, and maintenance of a public airport facility and a public airport access road.

In accordance with 19 AAC 90.430 and .440 the Commissioner approves the disposal of an interest in the parcels described above to the Department of Transportation and Public Facilities for the aforesaid purposes by the Department of Community and Regional Affairs.
