### NOTICE OF UTILITIES APPLICATION

The ALASKA PUBLIC UTILITIES COMMISSION hereby gives Notice that the CITY OF AKIAK d/b/a AKIAK POWER UTILITIES (APU) has filed an application for a certificate of public convenience and necessity (AP 067.000) to furnish electric public utility service in and around Akiaak, Alaska. The service area extends approximately 1/2 mile north of the village, 1/2 mile west of the village, 1/2 mile south of the landing strip. The service area includes the part of the village across the river (to the east) from the main part of town.

The filing indicates that APU will charge the following rates:

Hook up Fee	\$50.00
Reconnection Charge	\$30.00
Bad Check Charge	\$10.00
Meter Test Charge	\$10.00
APU's basic rate for non-metered customers	\$30.00
Energy Charge	\$0.35 per KWH

Although the filing indicates a 35 cent per kwh energy rate, the filing also shows projected energy costs of \$0.41 per kwh. It is possible that the higher rate will apply if the application is approved.

Because APU is a political subdivision of the state, it is exempt from economic regulation by the Commission. This means that the Commission has no jurisdiction over rates, quality of service, management practices, and customer complaints unless APU elects to be subject to the Commission jurisdiction (AS 42.05.711(b)).

The Commission anticipates that this application will be scheduled for open meeting on August 15, 1986. Affirmation of this meeting date will be furnished to parties of this proceeding.
