The ALASKA PUBLIC UTILITIES COMMISSION hereby give notice that the ALASKA VILLAGE ELECTRIC COOPERATIVE, INC. (applicant) has filed an application (Cause No. U-72-53) for an amendment of Certificate of Public Convenience and Necessity No. 169 to add Kaltag, Noatak, New Stuyahok, Shungnak and Wales to its existing authorized electric service area. The applicant proposes to install single phase 7200 volt primary, 120/240 volt secondary distribution systems in those communities and its existing tariff will apply. The rates are:
