Notice is given that the Alaska Commission on Postsecondary Education, under authority vested by AS 14.48.050, proposes to amend regulations in Title 20 of the Alaska Administrative Code, dealing with Institutional Authorization, to implement AS 14.48.050(7), as follows:

20 AAC 17.020(c) is amended to specify that the deadlines for applications from institutions for authorization to operate is the last day of the calendar quarter, pending the commission meeting at which the application is to be considered.

20 AAC 17.025 is amended to specify that the deadline for submitting requests for renewal of authorization to operate including accompanying documents and renewal fee is the last day of the calendar quarter preceding the quarter in which the current authorization is scheduled to expire.

Notice is given that the Alaska Commission on Postsecondary Education, under authority vested by AS 14.43.105, proposes to amend and adopt regulations in Title 20 of the Alaska Administrative Code, dealing with the Scholarship Loan Program, to implement AS 14.43.105, as follows:

20 AAC 15.038(2) is amended to clarify that loans will not be awarded for any flight instruction, including collegiate, which leads to a private pilot's license.

20 AAC 15.045(m) is amended to specify that in a flight school program only one loan will be awarded per certificate or rating.

20 AAC 15.055(a)(6) is amended to specify the conditions of a disability deferment.

20 AAC 15.055 is amended by adding a new paragraph (e) to specify that loans in default are not eligible for deferments under this section.

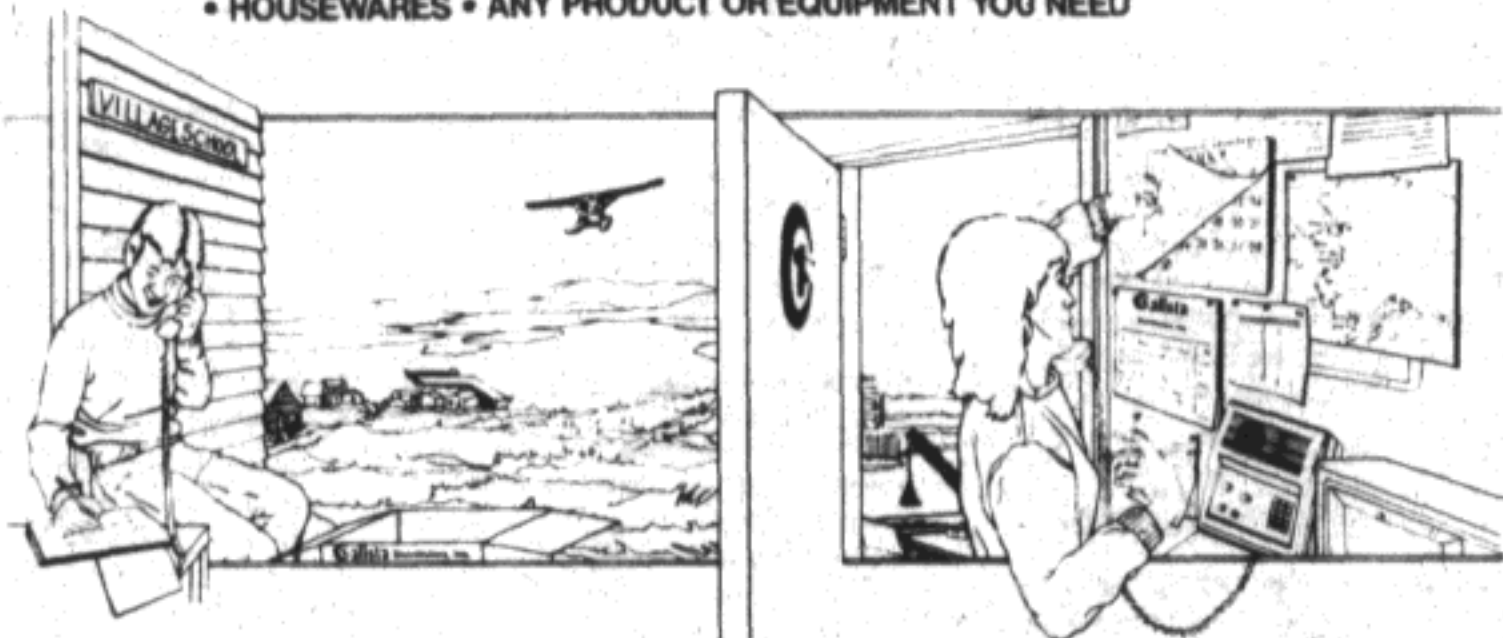

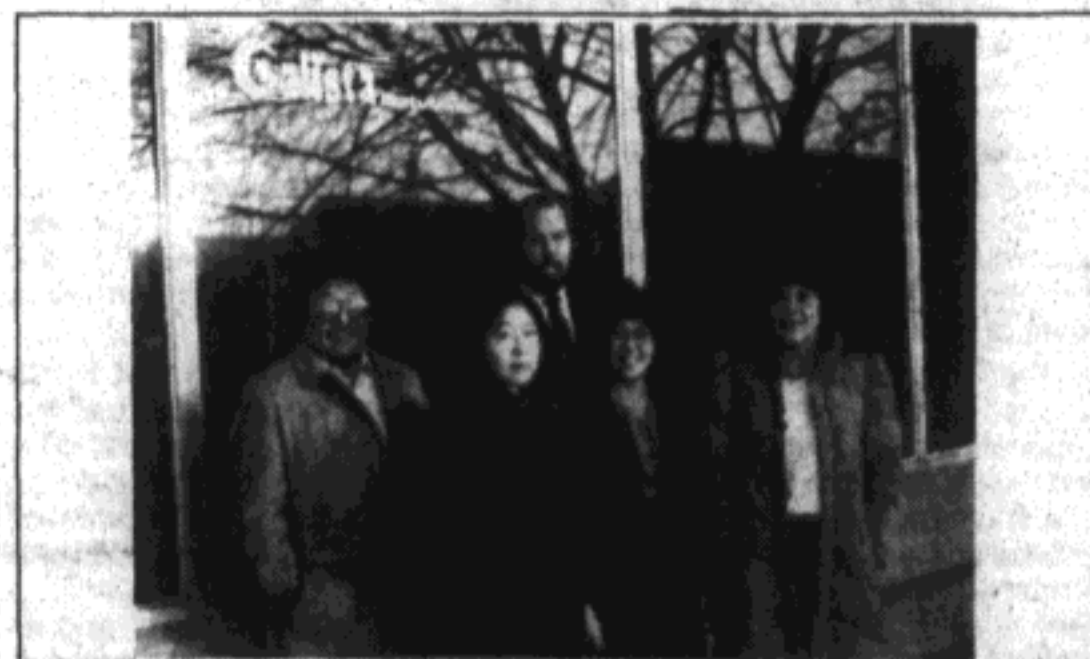
