### NOTICE OF PROPOSED DESIGNATION OF BERING STRAITS ECONOMIC COUNCIL AS AN ALASKAN REGIONAL DEVELOPMENT ORGANIZATION

Notice is hereby given that the Bering Straits Economic Council (BSEC) has applied to the Alaska Department of Commerce and Economic Development for designation as an Alaska Regional Development Organization (ARDOR) in accordance with the Alaska Regional Economic Assistance Program, AS 44.33.026, and the provisions of 3 AAC 57.060.

Upon designation and funding, the ARDOR will be responsible for providing services designed to encourage economic development to communities and businesses in the region, collecting and distributing economic information relevant to the region, and serving as a liaison between government and the region.

The region covers House District 22 which includes the entire Bering Straits Native Corporation region. The ARDOR will be administered by the Bering Straits Economic Council Board of Directors which is comprised of not less than 13 appointed and elected representatives of the region's economic, political and social interests.

Notice is also given that any person interested may present written statements or arguments relevant to the proposed action by writing to the Alaska Division of Business Development, Department of Commerce and Economic Development, P.O. Box D, Juneau, Alaska 99811, so that they are received no later than January 8, 1990.
