The ALASKA PUBLIC UTILITIES COMMISSION hereby gives notice that BARROW UTILITIES AND ELECTRIC COOPERATIVE, INC., has filed applications for certificates of public convenience and necessity to furnish sewer utility service (Docket U-75-36) and water utility service (Docket U-75-37) within the city and environs of Barrow, Alaska, more specifically described as follows:

Township 22 North, Range 18 West —  
Sections 4 through 9 and 17 through 20  
Partial Sections — West 1/2 of 3, W 1/2 of 10, N 1/2 of 16, N 1/2 of 29 and N 1/2 of 30.

Township 22 North, Range 19 West —  
Sections 12, 14, 14, 22, 23, and 24  
Partial Sections — N 1/2 of 25, N 1/2 of 26 and N 1/2 of 27.

Township 23 North, Range 18 West —  
Sections 21, 22, 27, 28, 29, 31, 32 and 33

(All the above with reference to the Umiat Meridian)

That applicant is at present providing sewer and water utility services under the authority of temporary certificates which were granted in August 1974.
