## SPECIAL NOTICE FROM THE ALASKA DEPARTMENT OF LABOR

DUE TO THE CURRENT HIGH RATE OF UNEMPLOYMENT, THE FOLLOWING SPECIAL PROGRAMS HAVE BEEN PUT IN EFFECT TO PROVIDE FINANCIAL ASSISTANCE TO THE UNEMPLOYED.

SPECIAL UNEMPLOYMENT ASSISTANCE (SUA)

This program provides unemployment compensation to individuals who have worked in jobs not covered by the regular unemployment insurance program. Funds are provided by the Federal government. (SUA effective December 22, 1974)

EXTENDED BENEFITS (EB)

This program provides additional benefits to persons who have exhausted their regular unemployment benefits, or who have an expired benefit year (expired after January 18, 1975) and have not earned enough wages to requalify for regular benefits. EB, when added to regular benefits, provides up to 39 weeks entitlement. EB costs are shared by the State and Federal governments. (EB effective January 19, 1975)

FEDERAL SUPPLEMENTAL BENEFITS (FSB)

This program provides additional benefits to persons who have exhausted EB entitlement. FSB, when added to regular and EB benefits, provides up to 52 weeks entitlement. FSB funds are provided by the Federal government. (FSB effective January 19, 1975)

## On the Inside Looking Out -

# Tlingit Indian New BLM Officer

Lloyd Sutton went to work for the Bureau of Land Management recently.

Taken at face value, that fact is not remarkable. But for Lloyd Sutton, a Tlingit Indian from Southeast Alaska, working for the BLM is like being on the inside looking out for the first time.

Sutton is the Anchorage District's new Native Liaison Officer, a role which will find him working as a mediator, interpreter and ombudsman in the BLM's administration of the various land settlements of Alaska's Native

Funded under the Alaska Native Claims Settlement Act (ANCSA), the law which recognized the Native's aboriginal title to the land, the position of liaison was created to help bridge the gap between the two cultures intertwined in the law. Sutton sees the job presenting an opportunity to initiate some real communication between the Government and the Natives and hopefully to make the

Government more responsive.
"Up to this point, the Native by and large has felt the Government policies were a mandate instead of management will hopefully promote some understanding of the Native in the bush and insure that Covernment policies reflect that Government policies reflect

his needs."

At 42, Sutton brings to this job an interesting blend of experience in the white man's world and leadership in the Native cause. A former Project Hire counselor for the U.S. Army's Alaska Native Hire program, he has worked for various comeercial enterprises as well, including Universal Services and Alaska Marine Equipment.

one of the adhoc committee of organizers for the Alaska Federation of Natives first convention in 1966, Sutton has been active in the Cook Inlet Native Association, the Alaska Native Brotherhood, and the Tlingit-Haida Association of Anchorage Through these groups. Anchorage. Through these groups he represented the Alaska Native point of view on Indian health advisory boards at the local, regional and national levels. From 1969 to 1972, he served as an adisory board member to the Secretary of Health, Education and Welfare and was on the

President's committees on mental retardation and nutrition, food and health. In addition, Sutton has been a member of the State Comprehensive Health Advisory
Council since 1969

Sutton's first task as liaison officer will be to accompany BLM realty specialists to Dillingham for meetings on easements and trespass actions on Native lands.
As a former fisherman and cannery worker there, he expects that his appearance among a

group of strange faces will put the local residents at ease and create a favorable atmosphere for exchanging information about the easement question.

"Western law has come to the bush and the Native is slowly beginning to realize the implication it will have," he says.
"This is the time for the Native to ask many questions and prepare for the future impact upon his culture."
