##### ON THE STATUS OF WOMEN

##### REQUEST FOR PROPOSALS

The Alaska Commission on the Status of Women was established by the legislature in order to address the problems, needs and contributions of Alaska's women; to make recommendations to state government addressing these needs; to increase the involvement of women in leadership roles; and to collect relevant data. It is the Commission's belief that regional conferences are an efficient and meaningful way of achieving this goal.

The Commission is directed to help all women organize and assume leadership roles. The Commission represents all women in Alaska. Rural women, whose needs and problems are unique, generally lack access to forums because of the geography of the state and the vast distances which must be traveled. The Commission feels that emphasis must be placed on conferences which bring rural women together in order to: increase the involvement of rural women in leadership roles; to establish or strengthen local women's networks; to discuss common concerns; to make recommendations for improving the status of rural women; and to present such recommendations and resolutions to the Commission on the Status of Women in a final conference report submitted within 30 days after the conference is held. The Commission hereby requests proposals from groups or organizations to hold regional women's conferences in rural locations throughout the state with particular emphasis on the locations of Nome, Kodiak, Southeast Alaska and the Aleutian Islands. It is anticipated that the Commission will award contracts for four conferences at an amount not to exceed \$2,000 per conference.

The meeting will also include an explanation of the Land Disposal Bank process and will serve as a forum for acceptance of nominations into and out of the Land Bank.

Each proposal must include the following:

1. A description of the steering committee submitting the proposal, and any prior experience of steering committee members in organizing similar types of activities. The steering committee must contain representatives from a cross section of women's organizations in the community(s) where the conference is planned. Such groups would include Native Sisterhoods, church women, political organizations, women's resource centers, service organizations, civic, professional or other community groups. The proposal should include steering committee member names, organizations that they represent and any other pertinent information.

2. The name or description of the region where the conference is to be held, including the names of villages to be included in the conference. A region is defined as an area with a population of 2,000 or more, or an area including at least four villages or towns.

3. Proposed dates and location for the conference.

4. Proposed conference topics, including at least one workshop on identifying local women leaders and role models, and the type of conference activities planned.

5. A description of the efforts to be made to inform and invite women from the region to take part in the conference such as offering travel and housing assistance, advertising on television and radio, placing ads in local newspapers or in local stores, post offices, hotel lobbies, etc.

6. Proposed sources of additional funding, or fund raising efforts planned.

7. A plan for conference evaluation by participants.

8. A plan for recording in written or taped form the major conference activities and any resolutions or recommendations made by the participants. All such resolutions are to be submitted to the Commission in a final report within 30 days after the conference occurs. (See below)

9. A budget with specific costs of items by category, including a

breakdown of how figures were estimated. State funds may not be law be used for food, beverages or day care.

#### FINAL REPORT:

A final report must be submitted to the Commission for editing and printing within 30 days after the conference is held. It shall include a brief description of the conference activities and a copy of all resolutions and recommendations passed by conference participants. The report is necessary for the Commission to act on recommendations in a timely manner. Final payment of the contract award will be withheld pending receipt of this report.

Commission staff will be available to all contractors to provide technical assistance in conference planning.
