Notice is hereby given that the Department of Community and Regional Affairs, under authority vested by AS 44.47.160, proposes to amend regulations in Title 19 of the Alaska Administrative Code to amplement AS 29.53.020 (f), as follows:

follows: 19 AAC 35.120(6) is amended to read as follows:

"Ownership" means that an applicant is possessed of an interest, other than a leasehold in real property, including a mobile home, which interest is recorded in the office of the district recorder, or, if unrecorded, is attested by a contract, bill of sale, deed of trust, or other proof in a form satisfactory to the local assessor."

Notice is also given that any person interested may present written statements or arguments relevant to the action proposed at Room 222, Goldstein Building, Juneau, Alaka, before 10:00 o'clock A.M., P.S.T., on March 16, 1973.
