

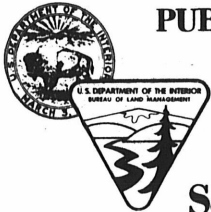
NOTICE OF MEETING

PUBLIC NOTICE

Easements on Native Selected Lands

The Bureau of Land Management is gathering information pursuant to the Alaska Native Claims Settlement Act. Easement regulations setting forth new criteria were issued on November 27, 1978. The new criteria provide for: (1) the elimination of easements based solely on recreational use; (2) the identification of "major waterways," that is, any river, stream or lake having significant use in its liquid state by watercraft for access to publicly-owned lands or for travel between communities.

Existing easement recommendations must be conformed to the new criteria. Recommendations previously submitted for specific villages will be considered in the conformance procedures. The public is invited to submit, within 30 days any additional information concerning access-related easements or major waterways to Anchorage District Manager, BLM 4700 East 72nd Avenue, Anchorage, Alaska 99507 for the following villages:

AMENDED NOTICE OF UTILITY TARIFF FILING

The ALASKA PUBLIC UTILITIES COMMISSION hereby gives notice that ALASKA VILLAGE ELECTRIC COOPERATIVE, INC. (AVEC), an electric utility, has filed a tariff revision (TA19-169) which revises the utility's line extension policy. Among the revisions are the following proposals:

(1) To add definitions for actual cost, application, contribution in aid to construction, and economic feasibility;

(2) To consider any service to be used for less than three years as temporary and to require applicants for temporary service to pay AVEC an amount equal to AVEC's estimated cost of installation & removal;

(3) In the case of facilities to be owned or operated by others within three years, to require the customer actually constructing the facilities to bear the actual full cost of construction of the line extension unless a suitable long term power purchase contract with adequate security provisions guaranteeing recovery of investment is entered into by the second party prior to construction;

(4) To require all construction by contractor or others to be performed in accordance with electric codes;

(5) In the case of construction site power/construction camp power, to require the contractor customer to bear the entire cost of service, including installation and removal of service equipment.

(6) Generally to base economic feasibility on 1% of the investment (a reduction from the current 3% of the investment) as a monthly minimum bill.

(7) Except as otherwise provided, to construct without special provisions permanent extensions whose costs are \$4000 or less (an increase from \$500 or less);

(8) To subject to special review and prior approval any extension of more than 500 feet from existing distribution facilities or across any surface water;

(9) To require permanent consumers requiring substantial electric facility investment to sign a service contract for a term of years.

Any interested person may file a statement of views favoring or opposing the tariff revision proposed by AVEC with the Commission on or before February 9, 1979. This statement should clearly affirm that the interested person has filed a true copy of it with AVEC as required by the Alaska Administrative Code.
