Project F-M-0537(1), Old Seward Highway-Huffman Road to Dowl-

ing Road Pursuant to Presidential Executive Orders 11990, Protection of Wetlands, and 11988, Floodplain Management, the Alaska Department of Transportation and Public Facilities provides notice of proposal to place fill material in wetlands and the base floodplains of two streams located adjacent to the Old Seward Highway between Huffman and Dowling Roads, The replacement of existing culverts at the stream crossings and minor modifications to the existing creek alignments are also proposed. The proposed project would entail extensive excavation of the existing roadway fill which will be replaced with clean granular fill.

The proposed excavation, fill, structures, and stream modifications are required for the general widening of the Old Seward Highway to a multi-lane facility with median, curb and gutters. The proposed improvements will provide efficient traffic flow and transit operation and improved safety for all transportation modes, including bicycles and pedestrians.

Approximately 88,700 cubic yards (c.y.) of fill would be placed over approximately 7.2 acres of wetlands intermittently along the project. Of this quantity, approximately 79,700 c.y. would be required to replace the existing roadway fill which presently covers about 6.25 acres of wetlands. The remaining 9,000 c.y, would be placed over approximately 2.1 acres of undeveloped wetlands. The most extensive area of wetlands involvement occurs between Dimond Blvd. and Abbott Rd. These wetlands have been classified as Developable under the Anchorage Wetlands Management Plan (AWMP), Activities in these wetlands will be covered under the U.S. Army Corps of Engineer's Section 404 General Permit. Minor wetlands involvement would also occur adjacent to the Old Seward Highway crossings of the North and South Forks of Little Campbell Creek, Approximately 8,500 c.y. of fill will be placed over .8 acres of wetlands adjacent to the North Fork of Little Campbell Creek, and approximately 8,900 c.y. would be placed over .8 acres of wetlands adjacent to its South Fork. Work in the wetlands in this area will require an individual 404 Permit.

Approximately 27,900 c.y. of fill would be placed in the base floodplains of the North and South Fork of Little Campbell Creek (quantity includes amounts of fill to be required to replace existing roadway fill within the floodplains). Both forks of Little Campbell

Creek would be modified by the proposed widening. A small section of the existing stream channels on each side of the existing highway would be covered by the proposed fill requiring that culvert alignments be adjusted to the additional highway width. To prevent stream bank erosion, riprap would be placed around all culvert end sections. All culverts would be designed to meet the U.S. Army Corps of Engineers 100 year flood criteria and be placed to allow for

fish passage.
