7. AAC is amended by adding Chapter 78, which contains provisions for the administration of the Department of Health and Social Services granting programs. Major sections specify eligibility criteria for grant application process, criteria and process for application review and grant award decisions, duration of grants, reporting requirements, monitoring of grant projects, grant termination, and appeals procedure.
