Sealed bids in single copy for furnishing all labor, materials and equipment, and performing all work on Project F-028186, Lathrop Pedestrian Overcrossing described herein, will be received until 2:00 p.m., prevailing time, June 1, 1972 in the Commissioner's Office, Department of Highways, Island Center Building, Douglas, Alaska.

This project will consist of the construction of a 237'-10" steel box girder pedestrian overcrossing across Airport Way in Fairbanks, Alaska.

All items of work consist of the following: 345 cubic yards of Class I Excavation for Structures; approximately 106 cubic yards of Class A Concrete, 8,160 pounds of reinforcing steel, 105,000 pounds of Structural Steel, 9,000 board feet of untreated timber, 3,400 square feet of roofing system, 4,500 square feet of glazing system and structure illumination system, lump sum all required; 80 square yards of Anti-spalling Treatment; and 165 cubic yards of foundation fill.

All work shall be completed in 140 Calendar Days.
