Qualification requirements to run for the Board of Directors of Calista Corporation are:

3. A candidate may provide in writing a brief resume and statement of goals and objectives to be sent to Calista Corporation.
4. The screening of applicants will be the sole responsibility of the nominating committee, utilizing criteria established by the Calista Board of Directors.
