This decision was reached after consultation with residents at a village meeting held in Tazlina on December 12, 1996, and upon weighing the best interests of those residents and any municipal corporation which may be hereinafter established in Tazlina and upon an application of the standards in 19 AAC 90.020.

In the same December 12, 1996 village meeting Tazlina residents also passed a resolution approving the subsequent. conveyance of the land by quit claim deed to the Copper River Basin Regional Housing Authority. The conveyance will provide the Housing Authority with site control for the 4 homes that already exist on the land. In accordance with 19 AAC 90.430 and .440 the Municipal Land Trust Officer, acting on behalf of the Commissioner of the Department of Community and Regional Affairs, approves the disposal of the above described land to the Copper River Basin Regional Housing Authority for site control of its existing homesites.

This notice is being distributed, posted and published in accordance with the requirements of 19 AAC 90.015(3), .420 and .910. The decision to accept the land and to subsequently dispose of a leasehold interest herein becomes final upon the expiration of 30 days after the publication, or the date of posting, whichever is latest, unless the decision is appealed to the Commissioner in accordance with 19 AAC 90.940.
