Proposed Sale 86, Beaufort Sea - The DO&G has issued a preliminary best interest finding and proposed Alaska Coastal Management Program Consistency Determination regarding proposed competitive Oil and Gas Lease Sale 86. The deadline for comments and information is **APRIL 1, 1997**. Sale 86 proposes to offer 202 tracts containing approximately 424,000 acres of tide and submerged lands and uplands located in the Beaufort Sea and on the North Slope between the Canning and Kogru Rivers. The sale is scheduled to be held on September 30, 1997.

DO&G will hold a **PUBLIC HEARING** regarding this proposed sale in Nuiqsut, Alaska at 7:00 p.m. on **FEBRUARY 25, 1997** in the Nuiqsut Community Center in Nuiqsut, Alaska.

Proposed Beaufort Sea Areawide 1999 - The DO&G has issued a 2nd call for comments regarding this proposed competitive oil and gas lease sale. DO&G invites the public to comment on any aspect of this sale. Submission will be used to draft the sale's preliminary best interest finding, the ACMP consistency analysis, and develop proposed terms and conditions. The deadline for comments and information for this phase of the public process is **JUNE 27, 1997**. The Preliminary Finding for this sale is scheduled to be issued in December 1998.
