Pursuant to Section 14(c)(3) of the Alaska Native Claims Settlement Act (ANCSA), 85 Stat. 688, AS 44.47.150(a) and 19 AAC 90.015 of the Municipal Trust Land Regulations, Council Native Corporation has offered to convey the surface estate, easements and rights to the land described below to the State of Alaska, in trust, for any municipal corporation hereinafter established in the Village of Council, Alaska:

Parcel 1 — The surface estate of a parcel of land on the north side of the Nukluk River containing approximately 240.9 acres. Excluded from this parcel are ANCSA 14(c)(1) claims, Native abutment claims, and 8 parcels of land to be retained by the Council Native Corporation. This parcel includes the Traditional Council building, the water well, the church and the proposed fire protection site.

Parcel 2 — The surface estate of a parcel of land on the south side of the Nukluk River containing approximately 43.9 acres. Excluded from this parcel are two parcels to be retained by the Council Native Corporation and a 14(c)(1) claim. This parcel includes the existing bulk fuel storage site.

Parcel 3 — The surface estate of a parcel of land on the south side of the Nukluk River containing approximately 1.2 acres. This parcel is adjacent to Hill Placer Claim U.S. Mineral Survey 1152 and provides access to the Nukluk River.

Parcel 4 — The surface estate of a parcel of land on the southern bank of the Nukluk River and adjacent to E94 22 s BLM 1 acre site easement. Containing approximately .87 acres.

Parcel 5 — The surface estate of that portion of an unnamed island in the Nukluk River, lying upland of the ordinary high water line of the Nukluk lying downstream of a line extending N46°W from Corner No. 3 of Hill Placer Claim U.S. Mineral Survey 1152. Said parcel contains approximately 7.88 acres.

Parcel 6 — The surface estate of a parcel of land on the northern bank of the Nukluk River containing approximately .7 acres. This area is known as the old barge landing site and is adjacent to Mineral Survey 2317.

Parcel 7 — An easement for an existing road on the north side of the Nukluk River, 25 feet in width, containing approximately .06 acres. This easement is across a parcel of Corporation retained land.

Parcel 8 — An easement for an existing road on the south side of the Nukluk River, 25 feet in width, containing approximately .15 acres. This easement is across a parcel of Corporation retained land.

Net area of the surface estate described in Parcels 1-8 is approximately 252.2 acres. The net area of the easements described in Parcels 7 and 8 is approximately .24 acres. Aggregating approximately 252.44 acres.

A complete legal description and map of the above tracts is available for inspection at the Council Native Corporation office in Council, at the Department of Community and Regional Affairs Office in Nome and at the Municipal Land Trustee Program office in Anchorage, the address of which is stated below.

Pursuant to AS 44.47.150(a) and 19 AAC 90.015, the Municipal Land Trust Office, acting on behalf of the Commissioner of the Department of Community and Regional Affairs, has decided to accept the above referenced offer in complete fulfillment of the obligation of Council Native Corporation under Section 14(c)(3) of ANCSA including the acceptance of less than fee interest for the two roads, parcels 7 and 8. The acceptance of less than fee interest for the abovementioned roads is determined to be appropriate because no other interests in the land are needed for the roads. It is less determined that the interest of a future city will not be prejudiced by this acceptance. This decision was reached after consultation with the village of Council, Alaska; through the recognized appropriate village entity; upon weighing the best interests of those residents and any municipal corporation which may be hereinafter established in Council and upon an application of the standards in 19 AAC 90.020.

This notice is being posted and published in accordance with the requirements of 19 AAC 90.015(c) and .910. The decision becomes final upon the expiration of 30 days following the publication of this notice, whichever is later, unless the decision is appealed to the Commissioner in accordance with 19 AAC 90.940.

**NOTICE OF PROPOSED CLASS ACTION SETTLEMENT,
HEARING AND RIGHT TO APPEAR**

TO: ALL APPLICANTS FOR GENERAL RELIEF MEDICAL BENEFITS WHO HAVE BEEN OR WILL BE DENIED SUCH BENEFITS SOLELY BECAUSE THEY LIVE WITH CERTAIN SPECIFIED RELATIVES WHOSE NEED-BASED ASSISTANCE INCOME IS DEEMED AVAILABLE TO THE APPLICANTS.

Notice to the certified class described above is given pursuant to Alaska Civil Rule 23 and the order of the Superior Court for the 4th Judicial District in Fairbanks, Alaska as follows:

A hearing will be held before the Honorable Mary E. Greens, Superior Court Judge, in Court room D of the State Courthouse at 504 Barnette Street, Fairbanks, Alaska on April 27, 1987, at 2:30 p.m. (Final Settlement Hearing), to decide whether the terms and conditions proposed in a settlement agreement between the plaintiffs and the State of Alaska are just, fair and reasonable.

DESCRIPTION OF THE CASE

On May 14, 1985, Plaintiff Rochelle Gilbert, on behalf of herself and all others similarly situated, brought a lawsuit in the Superior Court in Fairbanks, Alaska against the State of Alaska, challenging certain regulations of the Department of Health and Social Services which caused the plaintiffs to be denied General Relief Medical (GRM) benefits.

Plaintiffs alleged that the Department's practice of deeming as available to GRM applications all need-based public assistance income of certain relatives who lived in the same household, was contrary to plaintiffs' constitutional and statutory rights.

A hearing on plaintiffs' motions for preliminary injunction and class certification was held on June 25, 1985. The Court issued its orders granting preliminary relief and certifying the class on August 1, 1985. The parties, by mutual agreement, stipulated to an amended description of the class which was approved by the court on February 14, 1986. The class is described as:

All applicants for General Relief Medical benefits who have been or will be denied such benefits solely because they live with certain specified relatives whose need-based assistance income is deemed available to the applicants. "Need-based assistance income" shall mean all income of a relative household member qualified for and certified to receive Supplemental Security Income (SSI), Aid to Families with Dependent Children (AFDC), State of Alaska Adult Public Assistance (APA) benefits.

For purposes of retroactive relief, a sub-class was also created of all class members "who have incurred medical expenses which would have been covered by properly issued General Relief Medical coupons."

In response to a discovery request by plaintiffs, the state sent a notice to all class members, as determined by a review of public assistance records, who had been denied GRM benefits from July, 1984 through July, 1985. Each member was requested to contact Alaska Legal Services Corporation if they wanted retroactive payment for medical expenses.

Following the issuance of the Preliminary Injunction, the Department of Health and Social Services amended its GRM manual and regulations regarding eligibility determinations in conformance with the requirements of the Injunction.

Attorneys for the plaintiffs and the state have entered into an agreement to resolve the remaining issue in the case (retroactive relief) and attorneys' fees which, to become effective, must be approved by the Court. Prior to the final hearing seeking such Court approval, this notice is published to inform all class members of the proposed settlement and of their opportunity to file objections to the settlement with the Court or to exclude themselves as members of the certified class. Failure of a class member to file objections or intention to be excluded from the class by April 17, 1987 will result in that class member being bound by the Court's final decision in this case.

TERMS OF THE SETTLEMENT

The proposed settlement between the plaintiffs and the state includes the following:

1. The state shall be permanently enjoined from applying its former rule of determining GRM eligibility by counting as available to GRM applicants other household relatives need-based public assistance income (see description of class above for definition of need-based public assistance income);
2. Retroactive payments shall be made to sub-class members who incurred medical expenses between July, 1984 and January 1986 and who provide receipts or other documentation to substantiate such medical expenses to the attorney for plaintiff by April 17, 1987;
3. The state shall bear costs of notice and distribution; and
4. The state shall pay plaintiffs' attorneys' fees as settled between the parties.

RIGHT TO APPEAR AND COMMENT ON THE SETTLEMENT

If you do not believe the terms of the proposed settlement are fair, you may object to it. Your objections and comments will be individually considered by the Judge. If you send them in on or before April 17, 1987. Objections or comments should be addressed to the Clerk of the Court and to the attorneys for plaintiffs and the state. The addresses are as follows:
