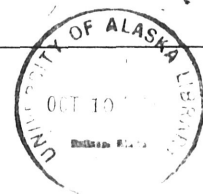

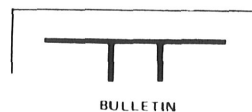
Fishermen organize to protest

Bering Sea Fishermen are meeting in Bethel on October 7 and 8 to form a Western Alaskan Fishermen's Association. The organization will also address the problem of the herring fishery which has been dominated by fishermen who are no Alaskan residents.

The organization will work on the development of fisheries regulations to gill net fishermen and will seek to find markets for fishermen.

The organizing of these fishermen is being spearheaded in

Bristol Bay by the Bristol Bay Native Association, Nunam Kitlutsisti, Jack Fuller (D) Nome, and Association of Village Council Presidents.

Tundra Times board changes

The board of directors of the Tundra Times, meeting in Anchorage, on September 26, has called for an annual meeting of the shareholders of Eskimo, Indian, Aleut Publishing Company, Inc., owners of the statewide Native Newspaper.

The meeting will be held at 8:00 p.m. on October 31, 1979 in Anchorage, Alaska, tentatively at the Anchorage Westward Hilton. Formal notice will be sent to shareholders on October 17, subject to concurrence of the representative of the Howard Rock Estate. Shareholders of record on or before October 17 will be entitled to vote their shares of stock.

This will be the first regular annual meeting held since 1975. The vast majority of the newspaper's stock has remained in the Estate of Howard Rock, late Tundra Times publisher, since his death in 1976. Shareholders will receive a report on the condition and operations of the corporation, and will be asked to elect nine directors to the newspaper's board.

The board accepted the resignations of two directors, Robert D. Arnold and Alfred R. Ketzler. Mr. Arnold had served on the board for two years and held the office of secretary of the board for most of that time. Ketzler was an original incorporator of the Tundra Times in 1962. The board accepted both resignations with regret, and unanimously adopted resolutions commending the former directors for their service and contribution to the newspaper.

The vacancy created by Ketzler's resignation was filled by the appointment of Nels A. Anderson, Jr., of Dillingham, to the board. Anderson, manager of the Bay Advertiser of Dillingham, is Majority Leader on the House.
