Two years ago we introduced an amendment to the foreign aid act which required that the Administration list in one place all the funds that our country

all the funds that our country is paying out for foreign aid through a multitude of programs. We said in a joint statement at the time, "The American taxpayer who is footing the bill for foreign aid should at least know what he's paying for."

Our amendment was passed into law in 1972, and we have just received the first report from the Administration on what the bill actually was for FY 1972. In that fiscal year our government paid out \$11,343,900,000 in grants and loans for military and economic add to foreign governments. aid to foreign governments (5,274,800,000 military and \$6,069,100,000 economic).
