The Indians, Eskimos and Aleuts of Alaska have institu-tionalized their strength through the formation of a statewide or-ganization, the Alaska Federa-tion of Natives. Increasing attion of Natives. Increasing at-tention has been given to max-mizing the means for the in-volvement of our people in the policy decisions that directly af-fect them. Thus we are working to shape all pertinent policies and programs that are being im-

plemented by the Federal and State Governments and private industry. We strongly believe that the emergence of the Alaska Natives is one of the most sig-nificant developments in the State of Alaska and portends definite progress in our efforts to achieve self-determination.

The \$3,000 grant made possible by the Week of Compassion Committee of the Christian Church (Disciples of Christ), will enable the Alaska Federation of Natives to effectively continue to address itself to the task of a just land claims settlement and reducing the disparities in the levels of health, education and economic viability of cation and economic viability of Native and non-Native Alaska. We welcome you to this effort and extend our appreciation for your concern and confidence.

The efforts of the Alaska Federation of Natives to achieve a just and equitable settlement of the long-pending Alaska Native Land claims is the number one priority lifem that is currently demanding the bulk of our time and attention. We are currently seeking to persuade Congressman James Haley of Florida, Chairman of the Sub-Committee on Indian Affairs, to report a claims bill out of his committee.

Any efforts to persuade Congressman Haley and Congressman Wayne Aspinall of Colorado, Chairman of the House Committee of Interior and Insular Affairs to act on a claims bill this session, would be most helpful. Enclosed is a copy of the position that is being advocated on behalf of the Alaska Federation of Natives.

You will be kept informed as to our activities and progress through the mailing of reports and newsletters. Further back-ground material is enclosed.


