REQUEST FOR PROPOSALS

The State of Alaska Department of Transportation and Public Facilities (DOT & PF), Construction Section, Northern Region is requesting proposals for a Professional Services Agreement for Land Surveying.

The services required are for surveying on the Taylor Highway between mile 23 and 43.

In general, the work will involve taking cross sections at 100 foot intervals of the excavation and embankment. It is estimated that cross sections will be required on 50% to 75% of the project. Centerline will be re-established using existing references, and elevations will be determined by using existing benchmarks.

All work will be performed under the direct supervision of a licensed surveyor.

All work must be complete within 60 days from the awarding of a contract.

An audit evaluation of consultants business may be conducted prior to negotiations for an agreement.

DOT/PF hereby notifies all respondents that it will assure that for any agreement entered into pursuant to this request for proposals, female and minority disadvantaged business enterprises will be afforded full opportunity to submit proposals and will not be discriminated against on the grounds of race, color, national origin or sex in consideration for an agreement.

Consultants will be required to provide proof of insurance coverage for professional liability, workers compensation, employer's liability, comprehensive general liability and comprehensive automobile liability.

The Department shall not be liable for any cost incurred by any consultant in response to this request for proposals or for any proposal development costs by any consultant to which an agreement is awarded. Work, and payment for work, will be authorized only upon issue of a notice to proceed by the DOT & PF project manager.
