The petition was sent to Tundra Times, Anchorage Times, BBNC, Village Corporation, AFN, and Congressional delegation, Ted Stevens, Frank Murkowski, Donald E. Young and most of all our President Ronald Reagan.

We hope that other concerned villages will do the same.

Following is the petition we the Contemporary Native Issue students drafted.

We the undersigned feel that the new Natives should receive stock in the village and regional corporations created by ANCSA. If new Natives do not recieve stock, then there will be no one to continue the corporation in the future. The new Natives will not care about the corporation because they will not be part of it. They won't own stock if they are not included in the corporation. They will not even be considered Natives.

We are not concerned about the value of our own stock decreasing on account of the new Natives being allowed in. The corporation will be strengthened with the inclusion of new Natives.

By allowing new Natives to be included in the corporation, the land, the corporation, and culture have a better chance of remaining in Native control.
