national organization designed to strengthen the Indian family.

The temporary name will be the "National Indian Women's Action Corps" or "NIWAC", "NIWAC's" first general as-sembly, including approval of in-terim officers and the constitution, workshop and discussions about objectives and procedures, will be held at the San Francisco Valencia Street, October 31, 1970, from 9 a.m. to 6 p.m.
Any Indian woman may be-

come a member of NIWAC if she is of duly recognized Native American descent, is interested in the purpose of the Corps, and is willing to take an active

The purpose of the organization is: to promote health, ed-ucation, and welfare, to preserve the culture and heritage, to ensure the religious and civil rights of the American Indian. An important objective is to pre-serve the beauty and protect the ecology of Indian lands.

The women plan to cooperate with existing Indian organizations in order to foster unity. This is to be a self-help organization geared toward encouraging Indian women to take a more active role in their com-

Mrs. Kalbrener, who gave her paper on Wednesday, October 21, described the sensory evaluation of commercial soy flours and of protein concentrates and isolates

Soy flour and derived pro-ducts have excellent nutritional qualities for food applications and are already used in many food products.
