PUBLIC NOTICE BIG GAME COMMERCIAL SERVICES BOARD

Requirement for Registration — Commercial Use Permit

On May 11, 1989, an act relating to big game hunting and to the regulation of big game and marine mammal guiding, outfitting, transportation, and other related commercial services became law. The legislation created a board entitled the Big Game Commercial Services Board.

Under this licensing act, a *Commercial Use Permit* is required for individuals who provide big game commercial services for compensation. Services provided that must have a permit include:

- provision of accommodations in the field at a permanent lodge, house, or cabin;
- hunt broker services;
- gear rental services;
- photographic or videographic services;
- other related services which may be defined by the board in (later) regulation.

IF YOU PROVIDE ANY OF THE ABOVE LISTED COMMERCIAL SERVICES, YOU ARE DEFINED UNDER THE NEW BIG GAME HUNTING LAW AS NEEDING A "COMMERCIAL USE PERMIT" AND YOU MUST HOLD SUCH A PERMIT TO PROVIDE BIG GAME COMMERCIAL SERVICES IN ALASKA.

This message is published to give all potential permit holders adequate notice of the requirements of the new law. Because the new law is now in effect, persons providing these services should apply for licensure *immediately*.
